Committee Chair responsibilities:

Hospitality – this person shall be responsible for welcoming new residents to the community and informing them of LCA membership. Also, the person will furnish refreshments at LCA meetings and events.

History – responsible for the LCA archives and all activities of a historical nature within the LCA boundaries.

Public Facilities – responsible for all matters concerning open space, streams, parks, playgrounds, and walkways within LCA boundaries.

Traffic – responsible for all matters concerning pedestrian and vehicular traffic within LCA boundaries.

Zoning – responsible for all matters concerning zoning or development within the boundaries of the LCA. This person will also be responsible for the implementation of the Lutherville Master Plan and for proposing changes.

Directors at Large – (2) responsible for recording attendance and related functions at LCA meetings. They will also encourage members of LCA to attend and participate in LCA functions.

By-Laws Article Five – Membership status shall be effective upon payment of annual dues.

By -Laws Article Nine – No member shall serve more than two consecutive terms in the same elected position. A term of office shall be two years.

By- Laws Ten – All voting members of the LCA may be nominated to run for any office or vacancy on the board. All members who wish to run in an election must complete and submit a biographical summary to the Nominating committee no later than April 1<sup>st</sup>.preceding the annual meeting.

## ZONING AND PUBLIC FACILITIES REPORT

As of the first of the year, the Roland Run Stream Restoration Project still had not received the necessary state and federal permits, according to the Department of Environmental Protection and Sustainability. The agency also reported that due to access limitations, the stream segment behind Trebor Court would not be restored. Should permits for the project be issued in the next couple of months, construction would likely begin after June 15, when a prohibition on in-stream construction ends.

## TOWSON UNIVERSITY BIG EVENT

The Lutherville Community Association has teamed with area churches and Towson University to offer an opportunity to community homeowners to benefit from the help of University students on their annual April 21, 2018 Big Event Volunteer Day. The event will run from 10 am to 1 pm. Homeowners whose projects are approved can have groups of students perform such tasks as raking, gardening/planting, trash clean up, stream clean up, mulching, outdoor painting, and hauling furniture, etc. to the roadside.

In order for a homeowner to apply for inclusion of their outdoor project, simply fill out an application on the Towson University Big Event website at <https://www.towson.edu/studentlife/activities/engagement/service/bigevent.html> under "Service Sites, Service Site Applications."

1. Big Event staff will visit the proposed project sites to determine if they are appropriate for the program. A committee of students will select the approved projects.

2. If a project is approved, then a team of students will be dispatched to the home on April 21, 2018 to perform the chores. Included will be a site manager who will be in communication with Towson U. staff. LCA will also have representatives circulating among the project sites.

3. Homeowners will have to provide any supplies necessary for the tasks such as paint, yard bags, mulch, etc. Students will come with work gloves.

4. Students are not allowed to operate any machinery such as lawn mowers or weed whackers. They are also not to perform any tasks inside the home or enter the home unless it is to use the bathroom.

We have identified several projects connected to area institutions that are candidates for the Big Event including improvements at Lutherville Elementary and the historic Colored School off Seminary Avenue. We are also arranging a collaboration between the Big Event and the Alliance for the Chesapeake Bay to clean up the area from Greenspring Avenue to the Lutherville Light rail station and south to Trebor Court and also along Bellona and Seminary Avenues on April 21.
